- Residents were not able to get answers or make progress at the monthly Council, Planning & Budget meetings

  - A) **BUILD A CASE AGAINST CITY ADMINISTRATOR**  
Documenting Neglect of Duties and Abuse of Tax Payer Dollars by City Administrator. Gathering all the facts to be brought to each individual Council member to force them to take a stand against the corruption.
  
  - B) **CLEAN UP OF OUR CITY'S NEGLECTED PROPERTIES**  
We discovered through outside sources that we have a local government that has completely neglected to adopt proper codes to deal with unsafe and disheveled properties in our city.
    - We have absentee landlords have never been dealt with and 30 years of neglect by our local government in adopting proper code to keep our city clean and safe.
    - One public inspector told me we have 20-30 properties that should be condemned.
    - Most cities have either a Uniform Housing Code or a Dangerous Housing Code, to help the state and county public inspectors and law enforcement do their job, but Lafayette's local government has not chosen to adopt either code. Therefore, Yamhill County housing authority and public officials can't address the numerous calls they get from desperate tenants in Lafayette living with mold, mushrooms growing on walls, and huge other safety issues.
    - Lafayette is Yamhill County Housing Authority's biggest issue but our local government doesn't take the steps necessary to take action, and therefore they can't help.
    - One public inspector for Yamhill County wants to help us and said they've "just been waiting for SOMEONE to come and rescue this town."
    - Sheriff Tim oversees the code enforcement officer and says his hands are tied. He mostly just relies on complaints by residents and can't do anything about disrepair and disheveled buildings. He can only enforce what's in our very weak municipal code. (Online, Chapter 5)
    - A big safety hazard is the countless properties that have no address on the front. The public. Inspectors have serious concerns about this in case of fire or emergencies in our town.

### **DUTIES OF COUNCIL AND CITY ADMINISTRATOR (See Org. Chart)**

The City Administrator is responsible to run the city efficiently, and is the *administrative* head of the city. The administrator is to perform the duties consistent with the Charter as directed by the Council and are to be accountable to the Mayor and the City Council.

*Our City Administrator, Diane Rinks, and has been employed by our city for almost 4 years. She was terminated from her last position as City Administrator in the city of Brownsville, Oregon shortly before being hired by Lafayette. She is a full time employee with a base salary of around \$60,000 and about \$20,000 in additional benefits. Information regarding her Brownsville termination is on the table.*

**With all the new subdivisions and added revenue to our city, why is none of it being reinvested into the community? Why have our streets, our parks, and our Community Center been allowed to deteriorate to the point that citizens are having to seek funding on their own to rescue our facilities?**

### ***WHERE IS ALL THE MONEY GOING?***

**On May 5<sup>th</sup> 2007, Residents held a Town Hall Meeting to address citizen concerns and all City Councilors were invited by certified mail to attend. NONE SHOWED UP. Since then, residents have continued to ask the Council to hold a town meeting to no avail.**

### ***DOES THIS SOUND LIKE A GOVERNMENT THAT IS WORKING FOR THE PEOPLE?***

**Our City Administrator was fired from the last city she worked for. Despite citizen concerns, our Council refuses to hold her accountable or monitor her spending. She violates our city Charter, Mission Statement, and the responsibilities laid out for her in the City Employee Handbook. Yet, the Council ignores citizens complaints.**

### ***ARE THEY WORKING FOR THE BEST INTEREST OF THE CITY?***

**The mayor *elected* by the people of Lafayette felt forced to resign for asking too many questions and communicating too openly with the public that elected him.**

### ***WHAT HAPPENED TO OUR ELECTED MAYOR FLOOD?***

**Water & sewer system questions continue to go unanswered, project failures go unaccounted for, and residents are beginning to take the issues into their own hands.**
