Angela Flood,

It has come to my attention that you clearly have far too much time on your hands to be conducting yourself in what amounts to be harassment of one of the candidates running for Sheriff of Yamhill County.

Let me make this disclaimer perfectly clear before I begin...I received an email from someone, not Tim Casey I assure you (which also means he is unaware that I am now in possession of this email I received), but directly from another person who was made privy to that email and forwarded it to me shall remain anonymous. This email contained certain highlights of some of your written exploits and your recent email directed at Tim Casey (which is addressed below later on in this response to you), his campaign staff and the deputies he works with.

You might be asking yourself why am I even writing this and/or why do I even care? That is a legitimate question, and this is my answer.

You did not, thus my response herein.

Now, as a glorified assistant of various insignificant types (as listed on your personal website listing your alleged skills and work experience), you clearly present or give off the clear impression that you think you know-it-all about elections, political campaigning, and the law...among other of your prima facie obnoxious rants and raves with the City of Lafayette, Oregon over the years (several popped up putting your name and Lafayette into Google). Before you altered the privacy settings on your Facebook page, I was able to view comments disparaging one of the candidates in a false light. Bearing false witness is a sin, as well as against the law (e.g. libel).

Hence the response Tim Casey's campaign staff received from the State that you copied and posted in your Facebook status feed.

Then you post that while you would never tell anyone how to vote, you in fact do so in support of your chosen candidate, Tim Svenson. You once again make unsubstantiated allegations (i.e. you proffer no facts to back up your assertions) against Tim Casey:

“Casey has made some pretty wild accusations regarding some things that have happened. If you hear anyone knocking Svenson because they heard that Casey said the Svenson campaign was mudslinging or being unethical, either set them straight or send them my way.”

There is/was nothing “wild” about the truth (is an affirmative defense) about the Svenson campaign and the letter he either wrote or approved to have written and his name and face tacked to it, which was published in a recent addition of the Chehalem Business Connection.

That letter was full of misinformation about the policies and procedures of how officers involved in shootings or officers under investigation for alleged criminal activities are handled; Svenson made a direct inference that should Casey become Sheriff and either aforementioned scenario happened involving an officer or deputy, that the other agency would investigate the other with the result of “nepotism,” “corruption,” “cover up,” “conspiracy,” and “dynasty building.” These allegations were not made solely at Tim Casey, but also Chief Brian Casey and by association the men and women who work for both respective law enforcement agencies. That, by definition is not only political mudslinging, it is also inherently libelous.

You then continue your rant as follows:

“When the voters [sic] pamphlet came out, there were a number of items Casey listed in the required part that seemed not right. So, I took that information and sent it to the state to check things out. I haven't heard back yet. That means they are either too busy to investigate it right now or they are considering formal charges. Lying on that part is a felony”

Did you ever stop to think that maybe the state found no basis in fact to your allegations and tossed it in the trash can, and rightly so!!!

Then you prove your ignorance on how campaign donations are given, used and reported with this statement:

“I also found out an ad placed in the newspaper that said it was from Deputies supporting Casey was really paid for by the Casey campaign. Legal but cheesy.” [sic]

When funds are contributed to a campaign, they come from the individual written to the campaign and then the campaign uses those funds to pay for ads, etc. The funds received are reported to be received by name and amount and letters are sent acknowledging receipt of their tax exempt donation. So naturally anything the campaign pays for with those funds are going to come out of the campaign account with the recognition of who provided those funds to pay for those ads. It's not rocket science and any rational person knows this as fact and would never accept your fiction on the subject.

The rest of your post is just too asinine and patently fallacious to dignify it with any further response.

However your email to Tim Casey previously mentioned, is case in point proving that you truly do have too much time on your hands – and – you do not know it all like you would have everyone believe.

“First of all, I think you should get an objective opinion regarding what mudslinging and dirty politics looks like before you keep using those phrases. Truth is an affirmative defense, and the letter published by Svenson in the Chehalem Business Connection was in fact unethical and contained several libelous statements therein. If anyone has legal standing to file a lawsuit it is Tim Casey, not Tim Svenson (the political mudslinger via this article, and that is a FACT that cannot be undone; it's now in print, circulated and acknowledged by the Newberg Graphic in a recent piece sent yesterday).

Defending oneself against the personal attacks of their political opponent is far from being a “professional victim,” especially when it is done so in a clean, ethical and professional manner. When the lies are exposed and the truth surfaces, the real culprit are exposed – Tim Svenson and his campaign staff (i.e. Ken Summer's ad with misinformation and half-truths meant to disparage Tim Casey and discourage voters from considering his candidacy for Sheriff).

Even former candidate Joe Shipley felt compelled not out of friendship but out of professionalism and ethics to correct the misinformation and half-truths printed about Casey by Ken Summers in his own ad; in addition to responding Lee Vasquez in a letter to the editor retorting to his lies and clear misinformation regarding Casey.

Like you, the News Register has been clearly biased from day one and colluded with the Tim Svenson Campaign to ensure anyone supporting Casey in writing was given to his Svenson's campaign staff to prepare responses to go to print the same day the paper would print the pro-Casey letters. This is reminiscent to your threat:

“Secondly, banning me from asking questions on your facebook [sic] page doesn't [sic] bother me a bit. Its [sic] really kind

“Also, if you are going to have someone write all the postings, [sic] signed with your name, you might want to proof read it first to make sure it doesn't come from both the 1st and 3rd person point of view within a single, [sic] long winded 'letter'. Given [sic] you want to run a professional office, being able to speak and write clearly is a requisite.”

Criticizing another’s oral or writing abilities proves that you have no legitimate argument to make. These types of responses are nothing short of bottom of the barrel ad hominem arguments.

Clearly you are just as unethical as those in the Svenson Campaign; and your support and vote for him speaks volumes to the inherent ignorant mindset of the true liberal democratic voter.
